1. Improvement of User Experience

It has been reported that the calibration requested by the battery interferes with the usability of the battery, as the calibration process takes up to 39 hours and cannot be interrupted. Under normal use, battery calibration is generally not necessary to ensure the long life of RRC standard batteries. Therefore, the calibration function has been removed.

2. Improvement of Hardware / Bug Fix

In rare cases, an unsuccessful charging completion was signaled even though charging was successfully completed. The improvement has resolved this issue.
